

# **Admissions Announcement for International Students at Tuition-Paying, Non-Scholarship Degree Programs**

## **First Semester of the 2026-2027 Academic Year**

In compliance with the regulation for the admission of non-Iranian, non-scholarship students approved by the Ministry of Science, Research and Technology of Iran on September ۱۵, ۲۰۱۵ (۲۴/۰۶/۱۳۹۴), Allameh Tabataba'i University (ATU) admits non-Iranian applicants for continued education as tuition-paying students for the first semester of the 2026-2027 academic year in the degree programs attached to this announcement, under the following terms and conditions.

### **1. Applicant Requirements**

#### **1-1 General Conditions**

1-1-1 Having a non-Iranian citizenship and holding a valid foreign passport;

*Note: Applicants with dual nationality (Iranian and non-Iranian) are not eligible for admission as international students.*

1-1-2 Possessing general eligibility approval (academic clearance) issued by the relevant authorities via ADAB platform.

#### **1-2 Specific Conditions**

1-2-1 Holding a valid high school diploma for admission into undergraduate (Bachelor's) degree programs;

۱-۲-۲ Holding a valid Bachelor's degree for admission into Master's degree programs;

۱-۲-۳ Holding a valid Master's degree for admission into Ph.D. degree programs

1-2-4 Having academic and professional qualifications in the requested field of study, approved by the respective academic department and the Admissions Committee;

1-2-5 Possessing a valid Persian language proficiency certificate at an upper-intermediate level or above (excluding applicants from Afghanistan and Tajikistan).

**Note:** Educational documents and transcripts from previous academic levels must be in Persian or English and certified by the Ministry of Foreign Affairs. Documents without official stamps or certified translations will be accepted only temporarily during the preliminary review phase. However, in case of successful admission and final enrollment, the applicant will be required to submit officially valid documents as described. Failure to submit the required documents shall result in the enrollment process to be cancelled, regardless of the initial admission decision.

**Note for Afghan Applicants:** Afghan applicants' high school diplomas must be stamped by the Ministry of Education and Ministry of Foreign Affairs of Afghanistan, and the Embassy of the Islamic Republic of Iran.

### **۱.۳ Crucial Points Regarding the Applicants' Persian Language Proficiency**

**A.** The final admission and registration of applicants for studying at Allameh Tabataba'i University shall be contingent upon verifying their Persian language proficiency. Therefore, in the event of a false claim by the applicant or international student recruitment agencies regarding an applicant's Persian language skills, appropriate action will be taken in accordance with the rules and regulations.

**B.** Applicants who possess the necessary proficiency to attend regular classes will participate in classes from the first semester of the academic year 2026-2027, after final admissions and registration and according to the university's standard procedures and educational regulations. These students are obligated to improve their Persian language skills concurrently with their studies by participating in the Persian language training courses offered by Allameh Tabataba'i University's Centre for Teaching Persian to

Speakers of Other Languages (CTPSOL, AZFA Centre). For more information on CTPSOL's educational courses, please visit <https://ctpsol.atu.ac.ir/fa> or call +982188962315.

C. Admitted applicants who do not possess the necessary Persian language proficiency to commence their regular classes will be able to spend the first semester of the academic year 2026-2027 studying and learning the Persian language at the university's TPSOL Centre. The academic status of these students during the first semester of the 2026-2027 academic year will be subject to university regulations. **No admission certificate** will be issued for this group of applicants **until** they commence their studies, and their final admission and registration will be conditional upon acquiring the necessary Persian language proficiency. The allowed period to achieve the required Persian language proficiency is one semester. Therefore, if admitted applicants fail to attain the necessary preparation by the start of the second semester of the 2026-2027 academic year, their admission will be considered null and void. These applicants will be required to pay the university's current fees in accordance with university regulations.

## 2. Admission Rules and Regulations

**2-1** Applicants currently enrolled in any higher education institution or university inside Iran under any status are not eligible to apply.

**2-2** Students who have previously completed and received a degree at a specific academic level (e.g., Bachelor's, Master's, etc.) from Iranian universities may not reapply for the same *level*.

**2-3** Applicants may submit admission requests before receiving a final degree at the previous level or before defending their theses/dissertations. However, final enrollment is conditional upon submitting the degree or the official thesis-defense report. Failure to provide these documents before final registration will result in the cancellation of the

admission process, and the university shall bear no responsibility for any preliminary acceptance.

2-4 All admitted students must enter Iran with a valid student visa, and their residency during study must be based on a student residence permit.

2-5 Applicants are allowed to choose only one field/major.

۲-۶ Applicants for Master's and Ph.D. degree programs may only apply to fields/majors related to their previous academic discipline.

**Note:** Applicants must be careful when choosing their desired field/major. Changing the chosen field/major after final registration will not be possible.

2-7 The capacity for admissions into various fields is limited, and selection will be finalized after academic departments' evaluations and the admission committee's decision.

۲-۸ The study method in all academic levels (Bachelor's, Master's, and Ph.D.) is taught program only (mix of Education and Research). Thus, ATU does not offer "Research-based" (thesis-only) programs.

۲-۹ Studying at Allameh Tabataba'i University is on a full-time basis. Admission of students through intensive, short-term, or similar programs is not approved by the university under any circumstances.

2-10 Applications without a valid **ADAB code** (specifically issued for ATU) will not be considered. Therefore, applicants must first register in the ADAB platform and obtain a tracking code before submitting any information to ATU's admissions platform. To register in the platform, please visit <https://adab.saorg.ir/PortalADAB/fa> and make sure to complete the registration until you receive a tracking code.

**Important Note:** In case it is discovered that an applicant or a recruitment agency has obtained multiple **ADAB codes** for the same applicant at different universities, their application will be canceled at any stage of the admission process.

۲-۱۱ It is mandatory to provide a valid and working email address in ATU's admissions portal.

**Note:** The account activation process will only be completed through the applicant's personal email address.

**Very Important:** Recruitment agencies must use the applicant's personal emails when submitting applications. Otherwise, the application will be excluded from the review process.

### **3. Application Method and Timeline**

3-1 Applications for tuition-paying programs are accepted only through ATU's international student admission portal. ATU does not accept documents submitted in person, by email, WhatsApp, or any other method.

۳-۲ Eligible applicants must submit all required documents via the university's portal from **Monday, 18 Khordad 1405 (June 8, 2026) to Friday 29 Khordad 1405 (June 19, 2026).**

۳-۳ The university's international student admissions portal can be accessed during the above dates through this link: <https://apply.atu.ac.ir>. To facilitate the application process, the portal is available in Persian, English, and Arabic languages.

#### **Important Note:**

Registration of applicants can only be done by licensed international student recruitment institutions or by the applicant themselves. Therefore, unauthorized individuals (such as intermediaries, etc.) are not allowed to register students in the system.

**File Size:** Above 50 KB and below 100 KB (Kilobytes)

**4-2 Scanned Copy of the First Page of the Applicant's Passport (valid for at least 6 months)**

**Dimensions:** 800x600 pixels (width\*height)

**File Size:** Above 50 and below 100 KB (Kilobytes)

**4-3 Scanned Copy of the Passport Validity Extension Page (if applicable, for Afghan applicants only)**

**Dimensions:** 800x600 pixels (width\*height)

**File Size:** Above 50 and below 100 KB (Kilobytes)

**4-4 Scanned copies of degree certificates and transcripts of records from previous levels**

**4-5 Résumé (Required for Ph.D. applicants)**

**4-6 Recommendation Letter (Required for Ph.D. applicants)**

**4-7 Persian Language Proficiency Certificate**

**Note:** Applicants must upload all documents clearly and according to the instructions.

**Note:** Applications submitted with blurred or unclear photos or those taken by mobile phones and not following the guidelines will be rejected, and the university shall bear no responsibility for reviewing these applications. Applicants are strongly advised to use a scanner to prepare and upload documents.

**Note:** Recruitment agencies must enter the agency's email in the designated section and the applicant's personal email in the appropriate field. Any application lacking a personal email or containing an invalid one will be removed from the review process.

**Important Note:** The university is committed to pursuing legal action against any conduct by student recruitment agencies found to be in contravention of the laws and regulations and deviating from the framework established in this announcement. Such activities will also be duly reported to the monitoring committee of the Student Affairs Organization.

## 5. Tuition Fees

To facilitate international students' payments and consider their financial affordance, ATU reviews the tuition fees for non-scholarship international students annually. Students might pay the final tuition in I.R. Rials (the official rate in Iran), as announced by the university's finance office during registration and each semester.

## 6. Student Welfare Services

٦-١ As approved by the University's Student Affairs Deputy, if there is available capacity in the university's dormitories and other welfare services, accommodation and meals for international students will be provided only for 4 semesters for master's degree students, and 8 semesters for bachelor's and doctoral students, upon collecting part of the related fees as described below:

The monthly accommodation fee for a 4-bed room is set at 55,000,000 (fifty-five million) I.R. Rials per person (based on a six-month academic semester). Dining charges are calculated and collected at a rate of 1,900,000 (one million nine hundred thousand) I.R. Rials per serving for standard meals and 2,300,000 (two million three hundred thousand) Rials per serving for premium meals.

The students successfully admitted into ATU will benefit from the university's dormitories, meals, and sports and welfare facilities in accordance with the rules, regulations, and decisions made by the Vice Presidency for Student Affairs.

## 7. Announcement of Initial Admission Results

7-1 After applicants register and complete their applications on ATU's Admission Platform, the applications will undergo initial verification by the International Student Affairs Center, and then be forwarded to the relevant academic departments or the international student admission committee for further evaluations.

After final review and feedback from academic departments or the committee, the results will be acknowledged, and applicants will be informed to proceed with final registrations.

7-2 Evaluation of Ph.D. applicants in all disciplines will include a mandatory scientific interview, as determined by relevant academic departments. Once the interview date is set (either online or in-person, depending on the department's decision), the university will inform the applicant or the recruiting institute of the decision.

**Note:** Failure to attend the interview session will be interpreted as the applicant's withdrawal from the process.

**Important Reminder:** Applicants must carefully upload the specified documents and enter accurate information during the online application process. If any submitted document or information is found to be wrong or invalid, the student's admission or study process will be revoked at any stage, and the university will not be liable for the tuition fees paid or the rejected admission.
